Submit either Form 4: Bid Securing Declaration OR Bid Security in bank draft/guarantee or Surety Bond callable on demand, as per IRR of RA9184.</p>	<p>Bid Data Sheet (BDS) Clause 16.1, under Section III of the Official Bidding Documents (OBD) should be written as follows:</p> <p>"The Bid Security shall be in the form of a Bid Securing Declaration (please refer to Form 4: Bid Securing Declaration), or any of the following forms and amounts:</p> <p>01. The amount of not less than THIRTY-FOUR MILLION EIGHT HUNDRED THOUSAND PESOS (₱34,800,000.00) ONLY, or 2% of the ABC, if bid security is in cash, cashier's/manager's check; or</p> <p>02. The amount of not less than EIGHTY-SEVEN MILLION PESOS (₱87,000,000.00) ONLY, or 5% of the ABC, if bid security is in bank draft/guarantee, irrevocable letter of credit issued by a Universal or Commercial Bank, or Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security."</p>
